## Plymouth Township supervisor resigns post

Members of the Plymouth Township Board of Trustees will meet at 10 a.m. Saturday to name an interim board president while the process of appointing a new township supervisor begins.

Last Sunday, beleaguered Plymouth Township Supervisor Richard Reaume submitted his formal written resignation to township officials, including Township Clerk Nancy Conzelman, as required in the township charter. In his two-page e-mailed letter, Reaume listed seven categories and touted innumerable accomplishments during his 10-year tenure. He was first elected in 2004, reelected in 2008 and again in 2012. His current term does not expire until

November of 2016.

Reaume's letter did not specifically address any of the current controversy or the recall action against him and three other members of the board. He stated only that he had given the matter a great deal of thought and that "at age 65" this was the "right time" for him to retire. Reaume's departure had been the subject of conjecture for months, particularly after he sold his Plymouth Township home this summer and purchased two condominium units in Florida. He has been living in a township

bed and breakfast for several months.

Reaume's administration has been fraught with conflict and controversy recently surrounding a protracted federal investigation of accounting practices relating to drug forfeiture funds in the police department. Currently, the Department of Justice has frozen about \$1.4 million in drug forfeiture funding, pending the outcome of the ongoing probe.

Reaume has also been criticized for his approval of a controversial \$2 million recreational plan for the township that includes an elaborate all-weather pavilion, an outdoor amphitheater with granite benches and a \$20,000 snowmaking machine. Residents have been protesting the plan

## Judge sentences 'evil' shooter to 27 years

In a plea deal with prosecutors, 22-year-old Andrew J. Nutt of Westland, will spend 27 years in prison for the killing of Plymouth Township senior citizen Kenneth LaBita.

Wayne County Circuit Court Judge Mark Slavens indicated from the bench last Friday that he was inclined to dismiss the plea bargain and proceed with a trial for felony murder and premeditated murder charges against Nutt whom he called "a coward."

Slavens said during sentencing that the crime is "one of the most despicable acts that I've ever seen." He told Nutt that his

actions were "evil."

In exchange for his guilty plea to second-degree murder and use of a firearm in the commission of a felony, prosecutors dropped the more serious charges.

Prosecutors had informed Slavens just prior to sentencing of threats Nutt made against his former girlfriend and co-defendant Miriah Pisarski, 20, of Wayne. The threats, prosecutors said, were made during recorded phone conversations Nutt had while in the Wayne County Jail. Pisarski was sentenced by Slavens to serve 2-5 years in prison for her role in the killing and robbery

of LaBita in his home last October. LaBita, 76, was shot once in the head and cash and firearms taken from his home. His body was discovered by Plymouth Township police officers called to his home on Gilbert Street east of Haggerty Road by neighbors, who suspected a problem when LaBita's dog was left outside for two days and his garage door remained open. Police later found about \$4,000 at Nutt's home when they executed a search warrant during the investigation.

Pisarski also accepted a plea deal from prosecutors which included her agreement to testify against Nutt.

## Police arrest 4 suspects in retail fraud ring

Shoplifting incidents in Westland, Canton Township, Dearborn and Garden City have been the work of five Inkster residents, according to an ongoing investigation by Westland police.

Four suspects in the thefts

have been arrested and charged following a call to Westland police at about 7 p.m. March 1 from the Kmart on South Wayne Road where store employees told officers that five individuals entered the store and stole four televisions.

During the ensuing investigation, Westland police were able to identify the subjects and detectives executed a search warrant at an Inkster residence where two of the stolen televisions were recovered, along with other property

that had been reported stolen in other shoplifting or retail fraud incidents throughout the area.

Westland officers arrested four of the individuals they

## Group collecting bottled water for Flint residents

Members of the Romulus Citizens for Social Change, a community activist group, are currently collecting bottled water for the residents of Flint where the water remains brown, odorous and unsafe to drink.

According to organizers and group member Virginia Williams, the group is attempting to do as much as possible for the Flint area where the water will remain undrinkable in many areas for another 12 months.

“We are just trying to help our neighbors. Nobody should have to endure this,” Williams said.

Last month, inspectors from the Michigan Department of Environmental Quality found that Flint is violation of safe water standards for excess trihalomethane, which is a byproduct of the disinfectant used to treat water from the Flint River.

Williams said few people in this area are really aware of the problems in Flint but that the Romulus group is encouraging everyone who is able to donate water for the residents of Flint whose water supply is unsafe.

In April 2014, Flint stopped purchasing already-treated Lake Huron water from Detroit to switch to the Flint River. The decision was planned to save an estimated \$5 million over two years while work was completed on the Karegnondi Water

Authority pipeline to Lake Huron. The change marked the first time in 50 years that Flint is responsible for the day-to-day treatment of drinking water

City officials have said that water tests have improved, but residents have steadily filed complaints about the smell, taste and color of the water, which remains unsafe, according to state inspectors.

Gov. Rick Snyder awarded Flint \$2 million-part of the state's \$8-million Financially Distressed Cities, Villages, and Townships Grant Program--to find leaks in city water lines and to replace a wastewater incinerator. That work has not been completed and Flint officials claim that more funding is necessary to correct the problems that caused the unsafe drinking water.

Williams said bottled drinking water for Flint residents can be dropped off at her home (734) 673 -8396, 35774 Abbey Dr. Romulus, from 10 a.m. until 5 p.m. Monday through Friday and from 1-4 p.m. on Saturdays or Darnell Hearst (734) 740 -2656, Thomas J Coleman Center, 35351 Beverly Road, Romulus from 9 a.m. until 4 p.m. Tuesdays.

Water can also be dropped off at Romulus Elementary School 32200 Beverly Road Romulus from 9 a.m. until 4:30 p.m. Monday through Friday.

The 45,000 square-foot, \$8.5 million facility was funded by use of Tax Increment Finance Authority revenue

## Native Quilts on exhibit

and the expense in light of conditions at the fire department during public meetings for months. Reaume also admitted to multiple false statements on a state grant application and was integral in a failed \$600,000 land purchase from the City of Detroit which a judge recently voided. Reaume’s handling of fire department staffing and union negotiations has also been the subject of public criticism and questions from the public during meetings.

Sources close to the situation said that Reaume’s decision may have been hastened by a loud altercation between township Treasurer Ron Edwards and Police Chief Tom Tiderington which took place last week in Tiderington’s office. The argument, overheard by several people, was apparently about the accounting procedures Edwards has implemented regarding the drug forfeiture funding in the police department, the subject of the ongoing federal audit. Tiderington did not respond to requests for comment.

Reaume, vacationing in Florida, reportedly would have to face another conflict involving Edwards, who is currently named in an assault charge by township resident Mary Ann McLaren. McLaren said she was accosted by Edwards when collecting recall signatures at township hall in mid-February.

That incident is part of an ongoing criminal investigation, which has been turned over to the state police by Tiderington.

In July 2011, Edwards loudly berated a police 911 dispatcher regarding a traffic tie up after July 4th fireworks, causing public criticism. In 2010, Edwards physically assaulted then Township Clerk Joe Bridgman in a widely publicized incident. According to court records, Edwards has been successfully sued by female township employees, resulting in financial settlements.

Edwards did not return calls seeking comment by press time.

At the meeting Saturday, after the appointment of a president pro-tem from the current elected board members, the board is expected to begin the process of interviewing individuals interested in filling Reaume’s unexpired term. It is expected the board will ask any interested township resident to submit a letter detailing their interest in the job.

If no successor to Reaume is appointed 45 days following his resignation, the Wayne County clerk can call a special election to fill the post, according to state law.

Current State Rep. Kurt Heise has expressed his interest in the \$111,384 position and said that he feels “the township is in crisis.” Heise said that if he is appointed as township supervisor, he will “regretfully” give up his state representative position, leaving an unexpired term.

Reaume will be prohibited from voting on his successor by state election law.

## Residents warned of fake callers claiming to be IRS

Canton Police are cautioning residents about continued fraudulent telephone calls from individuals claiming to be a representative of the IRS, INS or other government agency.

Government agencies and financial institutions to not ever call residents and demand information, police said, and residents need to be aware of this scam that is being reported across the country. A police spokesman also said that residents should be cautious and never give out financial information over the phone, particularly Social Security numbers, bank account or credit card information.

Police suggest that anyone receiving

one of these calls call the agency the individual claims to represent back at a number provided on a legitimate financial document or records. Do not call the number provided on a caller identification device as these individuals are programming the caller identification systems with false information to make it appear as if they are genuinely calling from the agency they claim to represent.

If you believe you have been the victim of a phone scam, residents should contact the Canton Police Department at (734) 394-5400. If you believe you’ve been the victim of a fraudulent income tax return filing you can also contact the IRS directly at 1-800-829-1040, police said.



Goerlitz has repeatedly attempted to get his car, which now has vines growing through the engine compartment and dried mud up to the bumpers, back from the city since 2007 when he heard that the friend with whom he left the car had been arrested for drunk driving and the car impounded. Goerlitz had traveled to New York for his job, and went to the police station as soon as he returned in an attempt to get his car back.

In his court documents, Goerlitz said he went to J&T Towing where he was told that the Belleville Police had to sign off on the vehicle which remained as evidence in a crime. When he contacted the Belleville Police Chief, he was told twice that the Wayne County Prosecutor's office was filing forfeiture paperwork to claim the car, according to his court filings.

No such forfeiture paperwork was filed and the car remained in storage for seven years at the rate of \$20 per day, something

or releasing the vehicle and therefore was responsible for the storage fees.

The city is expected to appeal the judgment.

“Belleville held the vehicle for seven years without any lawful authority,” Day said. “In September 2007, the criminal charge was over; it was no longer needed for evidence, and they didn't release the vehicle. It should have been sold or released.

“Somebody needs to pay for the damage to his car,” Day said, referring to the manner in which the car was stored.

## Evidence sale funds police firearm purchase

They may be sworn to protect and serve, but the Belleville Police Department also knows how to negotiate a good deal.

In exchange for a cache of rifles, shotguns and handguns confiscated as evidence, the department will be able to equip each full-time officer with a new Glock Model 17 semi-automatic pistol with Trijicon night sights and three magazines per weapon. The traded-in firearms, no longer viable as evidence, will be sold to

Top Gun Shooting Sports in Taylor for \$8,000. The new weaponry will cost the department \$6,492 and the remainder of the money used for holsters and other equipment, according to Police Chief Hal Berriman, who explained the arrangement to members of the Belleville City Council during a meeting earlier this month.

Berriman explained that the current weapons carried by officers were purchased prior to 2000 and while the firearms are still usable, many are showing wear and tear. In addition, he told council members, the advancements in weaponry in the past 15 years have prompted many departments including the FBI, the Michigan State Police and several other nearby local departments to upgrade the weapons used by officers.

In addition, he said, the weapons being sold were taking up space in the property room where room was needed.

“This money would not come out of our budget, nor cost the city/department any additional expenses,” Berriman said.

“It is important that our officers are afforded the best equipment to keep them safe and secure and prevent malfunctions from older and wearing equipment,” he said. “Also, with the department going to the 9 mm, we would have additional savings in the purchasing of ammunition and two officers will be trained as Armorers in the Glock to help keep down maintenance costs.”

The department plans to purchase 12 of the new Glock model sidearms. Berriman noted that the individual price for the weapons was at a discounted law enforcement rate not available to the public.

The sale and subsequent purchase was unanimously approved by members of the council.

The request for a security guard from staff members at the William P Faust Public Library in Westland has been approved by the Westland Library Board of Directors.

A security guard is on duty at city hall following a hostage-taking incident in 2013. Library officials said the employees of the company are former police officers who are well trained in dealing with the public and unusual circumstances.

## Wayne council expected to approve at-large council voting

Members of the Wayne City Council were expected to consider this week an ordinance allowing voters from the entire city to vote on council representatives from individual precincts.

New voting wards in the city have been designated following the approval of a charter amendment approved by voters last November.

With the implementation of the new wards, each councilmember will now be elected from the ward in which they reside. The question remains, however, as to who will vote on the candidates from each ward. Council members were expected to approve allowing at-large voting for all council seats and for the office of mayor.

According to community activist Ron Roberts, who began the petition drive to have the new ward system of voting on the ballot, along with term limits, the intent of the petitions was to have each council member elected from his own district by the voters in that district. A proposal from the election committee in the city, however, has

recommended that each council representative be elected at large, rather than by the voters in their specific district.

Roberts, who was on the election committee, said that this was clearly not the intent of his petition drive.

"This is an attempt to circumvent what the voters intended and what the petition language said," Roberts said.

There are now six wards in the city, rather than the previous seven. The new voting precincts cover the same general geographic areas as the wards. The 17,000 registered voters are now evenly distributed in the six precincts with no more than an 11 percent difference in the total voters between precincts, in accordance with state law. The precincts were devised by Stantec, an outside contractor.

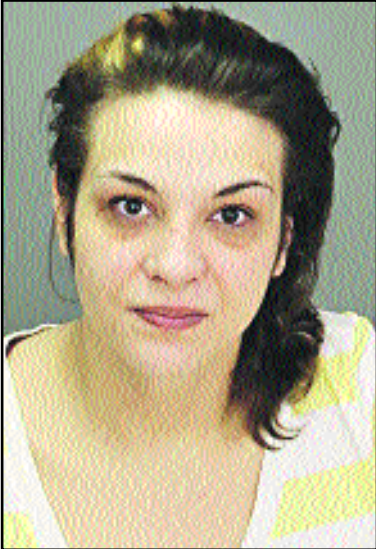
Roberts said he was contemplating legal action against the council in the form of some type of injunction should they attempt to implement voting at large for the council members from each precinct. He was adamant that the intent of the ballot question was to elect rep-

resentatives from each precinct by voters from that precinct.

The ballot language, however, appears vague on that point. Voters were asked to approve a change to the charter which requires the election of council members from the six precincts and that the candidates have their principal residence in the precinct at the time of their election and throughout their tenure. The ballot language does not specify that the electorate be from the district, although Roberts maintains that was clearly the intent of the change. He said he is "disgusted" with the proposal for at-large voting for council members.

"This is directly against the petition language and proposal. Everyone knows what the intent was," Roberts said.

New polling places have been established for precincts 1 and 2 at Hoover Elementary School at 5400 Fourth St; Precincts 3 and 6 at Wayne Activity and Banquet Center, 35000 Sims St and Precincts 4 and 5 and Taft-Galloway Elementary School at 4035 Gloria St.
