# Ford Road funding again rejected -11 We're not going to give up, that's for sure.

Last week, the U.S. Department of Transportation announced plans for \$500 million in road, transit, maritime and railroad projects across the country as part of the fed-eral TIGER program eral TIUER program (Transportation Investment Generating Economic Recovery). The application from Canton Township, which ited potential job creation and eco verv not among the chosen projects.

The plan from Canton would cost \$30 million, with an agreement from the Michigan

A study by the Mich Department of Transportation concluded that the solution to the traffic flow problems on Ford Road would be the reco figuration of the mad with a boulevard, separating opp ing lanes of traffic. Th That redesign would help control the high number of crushes reported on Ford Road by also eliminating left turn lanes at major intersections and creat-ing boulevard turnaround lones The study claimed that these measures would reduce th crashes and bottl that currently plague drivers especially during high-volume ffic hours
