County proposes sale of Eloise Property

Wayne County Executive Warren C. Evans announced the plans last week...

The Eloise Complex in Westland will be sold by Wayne County if a plan for consolidation of all county offices and services proposed by Wayne County Executive Warren C. Evans is finalized.

Evans announced the plans last week noting that the effort could eventually save nearly \$3 million annually in rent and maintenance costs and increase efficiency in services provided by the county.

The plan was proposed and is supported by a report produced by O'Keefe & Associates, which outlined how to better manage the county real estate holdings. The report examined how to reduce costs, better use existing properties, identify potential properties that could be sold, and reduce long-term

liabilities.

"This is the first time Wayne County has done a systematic review of its owned and leased properties," Evans said. "This report is another tool for making rational decisions on ways to cut costs and help to eliminate the county's budget deficit."

The first step in realizing the cost savings of consolidation will be the relocation of staff from 640 Temple to the Guardian Building, Evans said. Additionally, 18 leased county facilities, encompassing almost 750,000 square feet of space, are also in review for possible con-

solidation.

"Rationalizing the county's real estate holdings is an important continuation of my effort to reduce county expenditures begun with the hiring freeze I recently announced," Evans said. "With the county's current dire financial state, my office is immediately implementing opportunities to reduce county expenditures while preserving essential services."

The Eloise Complex, at 30712 Michigan Ave. should be sold and the property returned to local tax rolls, according to the report. The barn, greenhouses,

gardens and grounds at the Regional Educational Service Agency (RESA) facility in Wayne should be sold or turned over to the Wayne County RESA, according to the report.

Eloise was a large hospital complex located in Nankin Township. The name stemmed from the post office on the grounds which opened July 20, 1894 and was named Eloise after the postmaster of Detroit's daughter, Eloise Dickerson Davock. Eloise operated from 1839 to the early 1984 and started out as a poor house and farm but developed into an asylum and hospital.

In 1832 it was called the Wayne County Poorhouse; in 1872 it was the Wayne County

State police investigate violent Inkster arrest

Inkster Police Chief Vickie Yost has turned the investigation of a much-publicized violent drug arrest over to the Michigan State Police while continuing a department review of the incident.

Police videotapes of the arrest of Floyd Dent, a 57-year-old Detroit resident, were broadcast last week, showing Inkster Ofc. William Melendez pulling Dent from his vehicle and striking him about the head with his fists 16-18 times. Dent, according to official police reports, ran a stop sign in the area of South River Park Drive and Inkster

Drive at about 10 p.m. Jan 28. He allegedly did not immediately respond as the officers attempted to make a traffic stop but drove another four blocks. When Dent did pull over, he opened his car door as officers approached his 2011 Cadillac with guns drawn. Police reports indicate that Dent

made a verbal threat against the officers as he opened the car door, prompting their defensive actions, an allegation Dent and his attorney, Gregory Rohl of Novi, strongly deny.

The videotape, which has gone viral on the internet, shows Melendez pulling Dent from the car, executing and maintaining a choke hold on Dent while continuing to strike him in the head. Dent is using his right arm in an apparent attempt to shield

Firefighters save resident from burning home

The quick actions of Inkster firefighters were able to save the life of a 35-year-old man trapped in a house fire last week.

According to Inkster Fire Chief John D. Adams, the alarm came into the department at about 7:55 a.m. last Tuesday reporting a fire at 3106 Moore St. The property is located south of the Inkster Fire Station, Adams said, and firefighters could see a thick, dark column of smoke as they arrived with lights and sirens blazing at the address.

While enroute to the home, responding firefighters received word that a man was trapped in the home while another had jumped from a bedroom window to escape the blaze. The house was fully engulfed in flames with

heavy black smoke pouring through the front windows, according to official reports of the blaze.

Firefighters immediately performed a knock down to facilitate the rescue of the 35-year-old man who was located in a rear bedroom. The patient was lifeless and did not have a pulse when firefighters placed him in the rescue vehicle, Adams, who was on the scene, said.

“Our firefighter/paramedics along with assistance from our fire inspector who drove the ambulance to the hospital were able to reestablish his breathing. The patient had on two occasions gone into a Pulseless electrical activity rhythm (PEA) due to his extreme exposure to carbon

monoxide from the heavy smoke,” Adams said. Upon arrival at the hospital the Inkster paramedics had been able to stabilize the patient and he was breathing and had a pulse.

“A great save on their part considering how long he was in that toxic environment,” Adams said. The man is now in stable condition at Detroit Receiving Hospital, Adams reported last week.

total operation took 4 hours from start to finish,” Adams, who remained on site for the entire operation, said.

“It was extremely fortunate that the fire came in during a shift change,” he said. “Had that not been the case we would have not had the manpower of two shifts to facilitate such a quick rescue of the resident.

“On another side note, well into the operation our firefighters located a small dog and with some oxygen resuscitated him. He was reunited with the 77-year-old man who had earlier jumped from the window,” Adams added. He said the senior citizen suffered only minor injuries and was not transported to the hospital.

Killers of 2-year-old receive life sentences

The two men who killed a 2-year-old child on the porch of an Inkster home will spend the rest of their lives in prison.

Wayne County Circuit Court Judge Ulysses Boykin sentenced the pair, Raymone Bernard Jackson and Raphael Daniel-Jordan Hearn, both of Inkster, to mandatory life in prison.

Boykin told the court at the sentencing, “This is one of the most heinous crimes I have ever seen in my 45 years in the legal profession.”

The two were convicted of first-degree murder in the death of KaMiya Gross who was killed in July of 2014. The toddler was shot in the head at point-blank range in front of her father, Kenneth French, who was also wounded. A 12-year-old was also shot in the incident but

both French and the girl, now 13, recovered from their injuries.

French told the court that the shooting was in retaliation against him for an incident that took place previously at a club where he was working security.

He said that Jackson shot the child at the behest of Hearn who wanted him to see his child die as revenge for the earlier incident.

“Mr. Hearn was the one who encouraged Mr. Jackson to commit these crimes said Assistant Wayne County Prosecutor Jaimie Powell Horowitz.

Hearn was also convicted of charges including two counts of assault with intent to murder.

The two do not have the possibility of parole.

himself from Melendez' blows, preventing a second officer from handcuffing Dent's arms behind his back. Dent struggles against having his arm restrained and Melendez continues to pound his head with his fist. The three continue to struggle on the ground as a third officer arrives on the scene, kicks Dent and a fourth officer Tasers him in the thigh and stomach as he is being handcuffed.

Officers claim Dent was in an area known for drug trafficking and that they found drugs under the front seat of his car during a search after the struggle.

Dent and his attorney claim the officers planted the drugs and that they have additional video not yet made public showing that action by officers.

Dent said he was hospitalized for two days as a result of the injuries he suffered in the incident, including a fractured eye

socket. He was originally charged with assault, resisting arrest and possession of cocaine. After a review of the arrest videotape, 22nd District Court Judge Sabrina Johnson dismissed the assault and resisting arrest charges. Dent faced a court hearing on the drug charge in circuit court yesterday. The results of that hearing were not available at press time.

Yost said last week during a citizens' protest at Inkster City Hall that the department would “not hide from” the investigation.

“It's an ongoing investigation and we're waiting for the results of the investigation,” Yost said. “We're not scared of the facts. We'll follow them wherever they go and we'll take the appropriate action.”

She confirmed that Melendez, the officer seen striking Dent, is not assigned to street patrol as the department and state police investigation proceeds. Unconfirmed reports said that he was placed on administrative leave.

Michigan State Police Lt. Michael Shaw confirmed the ongoing state investigation into the incident.

Council rejects no raise proposal from commission

Members of the Wayne City Council, facing a \$2 million deficit budget next year, and an unsolved current budget shortfall, still want to be consulted about their wages for serving as elected officials.

A proposal from the Local Officers Compensation Commission to keep the current pay rates in place was soundly defeated by a vote of the council members earlier this month. Currently, city council members are paid \$2,850 and the mayor is paid \$3,192 annually.

During discussion of the formal recommendation from the commission members, council members complained that they had not been interviewed or allowed any input into the decision of the commission members. Councilman John Rhaesa was

vocal in his objection to the decision of the citizens committee complaining about the lack of council input into the recommendation. The seven member city commission meets every other year to consider the remuneration of all city officials.

This year, the recommendation was for no change in the annual pay. Rhaesa said that the commission members should have spoken to the council "to see how to better equip the council in the future." Rhaesa said he wasn't suggesting a pay raise, but that the commission members need to understand the scope of the elected officials' work. He suggested that the commission needed to be made aware of all the meetings he and others attend and that the mayor often pays the costs of attending meet-

ings in other communities.

Mayor James Hawley said that he felt it would be appropriate to look at the qualifications of those on the compensation commission. He said that the number of events the elected officials are expected to attend should be considered and that while the commission recommendation mentioned the current budget, the city doesn't yet have a budget for next year.

Budget cuts and spending

reductions, including a reduction in several city services, staff layoffs and the closing of the community center have been central to city council discussions for several months in an effort to close the financial gap. Recently, the city hired an outside consultant to help analyze the budget and help make the cuts necessary to balance city spending with reduced tax revenue.

Councilman David James said that it costs members of the coun-

cil more than the annual stipend to serve each year. James said he wasn't looking for a raise, but that more information was needed, prompting his vote to reject the commission recommendation. Councilman Al Damitio agreed and said that when he served on the compensation commission many years ago, the members talked to council about the recommendation. Damitio, however, cast the single no vote on the proposal to reject the commission recommendation.

City Clerk Matthew Miller said that he was unsure of how to proceed as the council members are asked only to vote to accept and file the recommendation of the commission. It requires a two-thirds majority vote to reject any pay rate recommended, which occurred at the meeting.

Alms House; in 1886 it was referred to simply as the Wayne County House. In 1913 there were three divisions: The Eloise Hospital (a mental hospital), the Eloise Infirmary (poorhouse) and the Eloise Sanitarium (a tuberculosis hospital) which were collectively called Eloise. In 1945 it was named Wayne County General Hospital and Infirmary at Eloise, Michigan.

In 1974 it had two divisions - the Wayne County General Hospital and the Wayne County Psychiatric Hospital. The psychiatric division closed in 1977 and in 1979 it was officially called

Wayne County General Hospital. At its prime, Eloise consisted of 78 buildings and 902 acres of land. Now only ruins, sewer lids with Eloise Hospital engraved on them, four of the 78 buildings and the Eloise Cemetery remain on the property, still owned by Wayne County.

Today the land that once was Eloise has been developed into a strip mall, a golf course, and condominiums. There are only two buildings currently in use. One is "D" Building or the Kay Beard Building. At one time this was an administration building and it was also used for psychiatric admissions and apartments for some employees like the Catholic chaplain. The old commissary building is currently being used as a family homeless

shelter.

O'Keefe also reviewed county parks and Department of Public Service and Drain Commission facilities. It did not issue a recommendation for the DPS and Drain Commission facilities "because they are functionally necessary for the operations of these departments."

The report didn't analyze the marketability of any of the parks and has no conclusions with respect to their use, future use, disposition or otherwise with two exceptions - Warren Valley Golf Course and Banquet Center in Dearborn Heights and the Inkster Valley Golf Course in Inkster. The report stated that "a determination should be made on whether these should be privatized by the county."

Wings charity game gets \$30,000 for arena

They may have lost the game, again, but they scored big for the community.

When the Wild Wings, led by Westland Mayor William Wild, took on the Detroit Red Wings Alumni team for the sixth annual game, they suffered an 11-4 defeat. The event, however, generated nearly \$30,000 for improvements and repairs to the Mike Modano Ice Arena where the contest took place.

More than 1,000 people crowded into the building to watch the game and participate in some of the contests and raffles.

"Even though the Wild Wings did not take home a victory this year, the event is considered a great success," Wild said. "This game is not only a great opportunity to bring the community together, but it also raises much needed funds for improvements to the Mike Modano Ice Arena."

The funding generated includes a \$10,000 contribution by former Red Wing and Westland resident Mike Modano for whom the arena is named.

"We are honored to host the Red Wings Alumni every year," Wild said. "Without all of you, this game would not be possible."

Sidewalk repairs set for township subdivisions

Canton Township residents who notice a green dot or two painted on their sidewalk can expect to receive a bill for repairs to the walkway. If the dots are red, the township will be paying for the repairs.

The township is expected to pay about \$493,500 for sidewalk repairs to Mattioli Cement Co. of

Fenton for sidewalk repairs in forest Trails, Hampton Court, Hampton Court West, all seven Windsor Park subdivisions and the Mayfair Village subdivisions. Most of the repair work will be billed back to residents, however, according to Supervisor Phil LaJoy. The township will pay for repairs deemed to be the respon-

sibility of the municipality and residents do have the option of using a contractor of their own choosing and paying directly for the repairs.

About 1,000 homeowners will pay an average of \$250 for the repairs to sidewalks that have been damaged by weather and wear or that slope enough to con-

tain standing water. The sidewalk repair program in the township has been in effect for about 16 years and began in the oldest township areas which were inspected to determine where work was needed. This year, commercial properties and businesses will also be affected by the planned repairs which had previ-

ously been limited to residential sidewalks in neighborhoods.

Canton hosted a public hearing on the sidewalk program last week which was sparsely attended. To request a second sidewalk inspection, residents can call (734) 394-5158.

The sidewalk repairs are slated to begin in May.

Settlement reached for defective roof material

Plymouth Township will receive \$127,000 toward the repair of the peeling paint on the metal roof of Township Hall and Fire Station No. 1.

The funds will come following the settlement of a warranty claim on the green metal roof filed by the township against Berridge

Manufacturing Co. which made the roofing material, installed in 2006. The manufacturer guaranteed the roofing material for 20 years. The \$127,000 is the estimated cost of sandblasting and re-coating the 33,500 square foot roof on the Township Hall and fire station.

Plymouth Township first filed a

warranty claim in July of 2013 but was offered only the cost of the original roofing materials, about \$40,000, minus depreciation for a total settlement offer of \$23,811. The township rejected that offer and had the roofing professionally inspected and tested by Roofing Technology Associates who found

that 82 percent of the panels on township hall and 93 percent of those on the fire station were defective. Berridge agreed to the new settlement amount after seeing copies of those studies.

Canton Township attorney Greg Demopoulos represented Plymouth Township and recom-

mended the settlement noting that taking the case to court could result in less money from the manufacturer. As part of the agreement, the township must release Berridge from any further claims under the warranty along with Roofing Technology, the roofer who installed the materials.

individuals and families with utility shut-offs, eviction notices, food, and clothing. In May, the St. John Neumann Journey to Housing program placed its first family as part of the program which helps the homeless become financially stable during a period of 18 months to two years. Weekly in-home case management offers assistance in developing budgets and formulating goals for each family.

"In the last several weeks we've had four homeless individuals come to our office in search of help," said Marie Morrow, Plymouth Community United Way president. "Journey to Housing helps

families regain stability."

Today, Journey to Housing is preparing to place a fourth homeless family in a house thanks to PCUW and donations from St. John Neumann parishioners.

"The first three are doing well, still in their homes and we're leading them to financial independence. Plymouth Community United Way makes it possible to support this special work," said Zaksek. "There's definitely an increase in homeless people in Western Wayne County because of the difficult financial times we've experienced. They've lost jobs. We're seeing people living in cars, couch surfing where they're sent from one family member to another."

In an effort to address these issues, grants were awarded to organizations committed to creating lasting change. Among the recipients were Plymouth-

Canton Community Schools (after-school tutoring program, Student Voice Leadership Group to teach skills and promote philanthropy through a hands-on service project, and GED study and test materials to enable adults to graduate). Growth Works provided substance abuse/dependency rehabilitation for youth and adults.

Additionally, Plymouth Canton United Way raised funds for partner agencies such as First Step, Angela Hospice, The Salvation Army Plymouth Corps, Community Opportunity Center (services for the mentally challenged), Plymouth Community Council on Aging, Plymouth Family YMCA, and Human Services

Collaborative (assists in crises cases). When families are in crisis they frequently need help from more than one agency. The nonprofits offer a variety of services from transportation for senior citizens to shelter and counseling for victims of domestic violence and their children.

Plymouth Community United Way raises funds year round to support programs for youth, senior citizens, developmentally disabled adults, and low-income and homeless individuals and families.
