Wright is completing his current four-year term while

Dalton is serving a two-year term and Pobur is completing the term of Meg Dooley who resigned from her four-year term as she moved from the city. Pobur, who previously served on the commission, was appointed to the seat by the commission members in September:

Following the August primary which will eliminate one candidate, the top eight votegetters will have their names on the Nov. 3 ballot. In that election, the top three vote getters will win four-year terms on the commission and the fourth highest vote total will win a two-year term.

The remaining three terms on the commission will expire in November of 2017 and include Mayor Dan Dwyer and commissioners Diane Bogenrieder and Oliver Wolcott.

Wayne voters will have two choices on the November ballot for the office of mayor. Current City Councilwoman Susan Rowe and Bob Boertje have each filed the required paperwork to be on the ballot.

Rowe made a bid for the mayoral office in 2011 against long-time Mayor Al Haidous, who voters returned to office. She has served on the city council for more than 10 years. The mayoral term is two years and Rowe has two years left on her current council term.

**Incumbent Mayor James** Hawley will not seek election to the position. Hawley was appointed to complete the remainder of Haidous' term when he was elected to a seat on the Wayne County Commission. Hawley could return to complete his term on the city council but has said he is unsure if the limitations on his time would allow him to take on that responsibility since he and his wife recently purchased a retirement home in Florida.

Filing election petitions for terms on city council were Christopher Sanders in Ward 1. Sanders was the only candidate to file and will run in the ward unopposed without the involvement of a write-in candidate from the same ward.

Also running unopposed from his ward is incumbent Councilman John Rhaesa who represents Ward 2.

In Ward 3, incumbent Councilman Lorne "Skip" Monit will face challenger Tom Porter:

The remaining two years on term of former Councilman James Henley will also be on the ballot. Henley resigned at the beginning of his term and David James was appointed to fill the council seat until the next regular election. James did not file to seek the remainder of the at-large term. Anthony Miller, who was appointed to fill Hawley's council seat when he was named mayor, will seek

in the mirror, you will still be there in the same body you are now, so you better fall in love with yourself."

Bachman, a well-known author and motivational speaker, is celebrating the release of his latest book, Walk This Way, Life Lessons For Dealing With Bullies and Bad Times, with a book signing and reception at E. G. Nicks on Forest Street in Plymouth from 5-8 p.m. next Wednesday, May 13. The book was originally released in October, but Bachman's speaking schedule delayed the celebration until next week.

Bachman is a familiar figure in the community, getting around in his specially-equipped van and on his small Amigo scooter.

Bachman said he believes we all need to live our lives on our own terms. For him, part of that philosophy included taking off the artificial legs he had worn as a child and going into the world just as he is. "I walked on my hands most of my life," he said

He attended elementary and middle school at Oakman School for the handi-

capped and always dreamt of a broadcasting career. He worked at several radio stations in the state and also worked at General Motors and Burroughs for awhile, he said. But in 1988, after a difficult divorce and winning custody of his daughter, Alicia, he finally followed his dream and enrolled at Specs Howard School of Broadcast Arts. Alicia, now 35, and the mother of Bachman's two grandchildren, wrote the forward to Walk This Way, which, he said, made him very proud.

A film documentary about his life in 1998 started his motivational speaking career and his efforts to speak to students in schools about bullying. He thought he was pretty much an expert after the taunts and jibes he endured during his childhood.

"Every day we hear more about bullying and now cyber bullying," he said. "The truth is, words have power."

In 2008 he was chosen by Energizer as the as a recipient of the National Keep On Going Hall of Fame award.

The morning began with a complimentary breakfast made possible by Tim Horton's, Dunkin' Donuts, Kroger #671 and #703, and Busch's. ## Budget includes closure of Wayne Community Center

Tonight and again next Tuesday, members of the Wayne City Council will consider a \$14.7 million budget for the community which includes the loss of two police officers and the closing of the community center:

City Manager David Murphy told the council members that the "biggest thing" in the budget was the closure of the remainder of the community center. He said even that action left the budget \$1.6 million short. His plan, however, did not meet with immediate favor of Councilman Al Damitio.

"We need to develop an alternate budget so we don't have to close the community center," said Damitio, adding there would be cost-savings by consolidating services into the building. Damitio proposed closing city hall and the engineering services building, which houses the Department of Public Works, and relocating those operations into the community center:

Murphy said that the proposed budget also includes the loss of two police positions in the city.

Mayor James Hawley said that the continued arguments to keep the community center operating could be unrealistic.

"I would love to keep the community center open but do you keep the community center open and lay off cops?" Hawley said. "The community center is very expensive to operate - more than city hall. There is a cost to relocate to the

The ice arena and the pool at the community were closed last year in cost-cutting measures. Completely closing the building would save about \$300,000 in annual expense to the city, after the basic utility payments have been made for the facility. The budget also includes a fee for maintenance of the city parks and ball fields. The city currently pays about \$644,000 annually in bond service for the community center building.

The city has been using funds dedicated to specific other expenses to offset the shortfall in the budget each year. Hawley said that those funds are nearly exhausted. He said that only the retirement fund, labeled Other Postemployment Employee Benefit Trust (OPEB), remains and those funds are earmarked to cover health care for city retirees, an expense estimated at \$1.9 million for the next fiscal year. That expense would leave only about \$300,000 in the fund, but could eliminate the \$1.6 million deficit in the general fund.

"We're balancing the budget with OPEB money - it's really running out. This is the last year we can do this," said Murphy. "We're balancing the budget off the fund balance. I don't consider it a balanced budget."

Council members accepted the budget for purposes of discussion and review but asked Murphy to present alternatives at the meeting next week.

## School board agrees to proposed district boundary transfer

A second vote of the Northville Board of Education to allow Woodside Village to become part of the Northville Community Schools was approved by a 4-3 vote.

The vote does not assure the transfer of students into the Northville district but demonstrates the willingness of the board to allow the students who live on the west side of North Haggerty Road between Five and Six mile roads to attend Northville schools rather than schools in the Plymouth-Canton district. Plymouth Canton Community Schools Board of Education members have voted against the transfer.

The final decision on the matter rests with the Michigan State Superintendent of Schools who would make the decision following the decision of a state administrative law judge.

The properties in question are in Northville Township and close to Winchester Elementary School and Meads Mill Middle School in the Northville district. If approved, there would 16 students who could transfer into a Northville elementary school and eight more who could move into the middle and high school.

A final decision on the issue from the state could be issued in June.

A petition from the Woodside homeowners claimed that 80 percent of the subdivision homeowners favored the move.

The motion was approved by a 4-3 vote of board members. Northville school board treasurer Matt Wilk was in favor of the request along with board members Scott Craig, Adam Phelps and Roland Hwang while board president Cynthia Jankowski and

trustees Ann Kalass and Secretary James Mazurek were against it. Wilk noted that the new students would bring added revenue into the district from state per-student funding which is estimated to be about \$200,000 if the projections of the homeowners' petitions are correct.

Opposing board members said they were concerned with the precedent that such an approval could establish and the effects of any increase in the student population in the Woodside subdivision. School boundaries in the district were redrawn due to the increased student population in Northville, despite the loss of 75 students last year.

Wilk said that the fundamental issue was that a group of parents feel their children would get a better education in Northville which should be a tribute to the effectiveness of the Northville district.



the remaining two-years on the term. He will be challenged by Lucietta Miles.

New changes to the city charter approved by voters have divided the city into wards with staggered terms. To seek office, the candidate must be a resident of the ward in which he is seeking election and remain a resident of that ward for the duration of his term. Only the mayor will be elected as an at-large candidate.

#### In Westland:

In Westland, 13 residents have declared their candidacy for the city council while four intend to seek the position of city clerk.

Current Clerk Eileen DeHart-Schoof announced her retirement last month. She is the first elected clerk in the city.

Wavne County Commissioner Richard LeBlanc, a lifelong Westland resident who formerly served on the city council and as a state representative, has submitted his paperwork to succeed DeHart-Schoof. Also seeking the clerk's job are Christopher Cox, Jody Rice-White and Zivka Wojtowicz.

The Aug. 4 ballot will reduce the field of candidates to two who will move on to the Nov. 3 ballot.

All four incumbents have filed to return to their offices, including current Council President James Godbout, Adam Hammons, Bill Johnson and Dewey Reeves.

Seeking a return to city government will be former mayor and city councilman Charles Pickering and former Councilman Dennis LeMaitre along with former Wayne-Westland Board of Education member Debra Fowkles. Fowkles also served on the Westland Civil Service Board to avoid a conflict of interest with her council candidacy.

Also seeking a term on the city council are Steve Boron, who ran unsuccessfully as a Libertarian and Republican party member for state representative, William Campbell, who sought a council term two years ago and Judy McKinney, a member of the Westland Disabilities Concerns group.

Christopher Coldren, Kevin Miller and Peter Herzberg will

also be on the primary ballot seeking to move on to the November election.

Voter will reduce the number of council candidates from 13 to eight. The top three vote getters in November will earn four-year council terms and the candidate with the fourth highest vote total serving a on the council for two years.

#### In Inkster:

Mayor Hilliard Hampton and incumbent council members Michael Canty and Marcus L. Hendricks have opted not to seek re-election to their respective posts, according to documents from the office of the city clerk.

Seeking the mayoral office will be local attorney Byron Nolen and Walter Starghill.

Seeking terms on the city

council from the six electoral districts in the city will be unopposed incumbent Timothy Williams from District I; Calvin L. Hayes, Charmaine Kennedy and incumbent Clarence Oden, Jr. from District II; Lorenzo A. Moner, Jr., Courtney Owens and Sandra K. Watley from District III; Jewell Jones and William S. Miller from District IV; incumbent Kim Howard will be challenged by Winston Wade from District V and from District VI, former City Councilwoman and **Inkster Board of Education** trustee Dee Richardson will challenge incumbent Dennard

During the primary election, voters in District II and III will reduce the candidates from their wards to two and those names will be on the November ballot.

documents," he said.

Doroshewitz said the original costs for the lot had doubled in price since it was first proposed in April of 2013. Since that original proposal, the 100 parking spaces to be located across from the park baseball fields, sledding hill and controversial all-weather pavilion, have grown to a total of 209 parking spaces, a new drainage system included and the original specifications for asphalt upgraded to concrete.

"I don't think it is a rounding error. I don't see how we can double the cost of the project," Doroshewitz said.

Another \$26,700 was OK'd for rubber groundcover at the township playscape.

Doroshewitz also called the lack of notice to the trustees "disrespectful" and said that these were discussions that should have taken place months ago.

Trustee Mike Kelly agreed.

"I would like to see more lead time on these projects," he said. "It seems like we're always rushing to get them in."

Treasurer Ron Edwards countered Doroshewitz' criticisms noting that the concrete lot would last far longer than the originally- proposed asphalt. Edwards originated the original proposal for the entire \$2 million recreational facilities project and has also been overseeing the construction of the all-weather pavilion which also doubled in cost. The total project will be funded by \$1.9 million in bonds and another \$550 in federal grants and private donations.

"We really believe for the community's sake that concrete is the best way to go," Edwards said. The estimated life of the concrete is 30-40 years while asphalt is 15-20 years, according to township engi-

Edwards said that the funding for the increased expense was available and included in the total project costs.

The familiar voting bloc of Clerk Nancy Conzelman, Edwards and Trustee Kay Arnold was joined by Supervisor Shannon Price in a 4-3 vote to approve both the expense and a review of the paving contracts by the township attorney.

The no votes were cast by Doroshewitz, Kelly and Trustee Chuck Curmi.

The project has also raised concerns of area residents who objected to the clear cutting of trees last week prior to the meeting of the board.

"I encourage people to visit McClumpha Park -there virtually is nothing left but concrete and buildings- the peace and tranquility of the former bucolic setting have been stolen from all residents. "It is devastating to see such a loss of our beautiful sanctuary for an amusement center," she said prior to the meeting of the board.



## City mourns loss of beloved business owner

Members of the Inkster community are mourning the death of well-known businessman Fedele Bello, the owner of Bello's Pizzeria, who died April 4.

Mr. Bello, 77, owned and operated his business in the community for more than 30 years. Born April 21, 1937 in Italy, he immigrated to the area in 1967 with his wife and two children. "His passion was his work and his family," his son said. "He helped keep so many young kids in Inkster out of trouble while giving them work to do. He had so many loyal customers from all



## School board members OK payments to employees


