# **Defamation lawsuit settled in Wayne**

The City of Wayne will pay community activist Christopher Sanders an undisclosed financial amount as part of a confidential settlement reached in the lawsuit filed against the city and Councilman Skip Monit by Sanders last vear.

The settlement includes a financial award to Sanders, 45, who filed the suit in October of 2013 in response to comments Monit made during a regular meeting of the city council in October of 2012. Monit's remarks

We wanted to make a statement and that's what we did.

It was not our intent to drain anybody financially.

included innuendoes of allegations that Sanders had made improper physical contact with children during a HalloWayne event celebrated in the city, according to court filings.

Sanders approached the city council and Monit at a subse-

quent 2012 meeting and demanded a public apology for the remarks, but his request received no response from the officials. He subsequently filed the lawsuit, represented by Canton Township attorney Ron Ruark, in October of 2013.

Following formal legal depositions of Monit, Sanders and several others, the matter was referred for a formal "case evaluation." Ruark said this is a step required of all civil cases in Wayne County. The evaluation is performed by a group of lawyers who determine whether or not to take the case to trial based on the merits of the legal filings. The evaluation in this case recommended the financial settle-

## **Township audit finally filed 5 months late**

The audit of Plymouth Township finances, due in the state treasurer's office no later than June 30, was finally filed last week.

Plante Moran auditors Mark Olejnik and Melanie Crowther reported on the financial condition of the township at the regular meeting of the trustees last week. Despite the five month delay, the auditors said that the report included an "unqualified opinion" from the financial professionals, meaning that they determined the records accurately reflected the financial activity and condition of the township.

the five-month delay in the required financial audit was caused by a lack of documentation from the City of Plymouth regarding amounts owed to the township for legacy costs in the Plymouth Community Fire Department. The two communities ended a joint operating agreement at the beginning of 2012 and township officials claim that the city owes about \$1.3 million in pension costs for retired firefighters and another \$2.5 million in health care costs for retirees. City officials have questioned the accuracy of the amounts claimed by the town-

Auditors said that the town-

ship ended 2013 with a fund balance of \$3.661 million, and had expenditures of \$850,000 less than revenue collected. Reported revenues were \$12, 126 million while expenditures were \$11,716, according to the auditors.

Olejnik told the trustees that a healthy fund balance was necessary to provide for cash-flow needs and the economic uncertainty. He urged fiscal restraint going forward.

Township Supervisor Richard Reaume said that the township revenue decreased by about \$6 million in revenue sharing from the state during the past seven years.

The auditors noted that 55 percent of the township revenue came from property taxes while administrative charges, cable revenue and other fees accounted for about 21 percent, or a little more than \$2.5 mil-

Public safety expenses accounted for 63 percent of expenditures in the township, totaling about \$7.09 million for police, fire and emergency dispatch services. General government expenses were reported at \$2.86 million, about 24 percent.

The township currently has an unfunded liability of more than \$20 million for retiree health care.

## **Detroit men found guilty of murdering teens**

A jury has found the two men accused of murdering Westland teens Jacob Kudla and Jourdan Bobbish guilty on all charges.

Township officials said that

The jury trial, ongoing for more than a week, came to an end last Thursday morning as the jury announced the guilty verdict to a packed Wayne

County Circuit Court. The two, Felando Hunter, 24 and Fredrick Young, 25, were each convicted of two counts of firstdegree murder which carries a mandatory life sentence without the possibility of parole. The two were also convicted of felony murder-committing a homicide

while committing a felony-as well as charges of torture, armed robbery, unlawful imprisonment and felony firearm. Young was also convicted of being a felon in possession of a firearm.

Witnesses in the trial told the jury that Kudla, 18, and Bobbish, 17, had visited Kudla's uncle in Detroit on the night of July 22, 2012. The pair then drove to a home on Algonac in an attempt to buy drugs from Hunter and Young. The men robbed the teens of \$110, forced them to

Murphy told council members that Maciag was well suited for the top job in the police department and said he was described by other police offi

cers and members of the community as meticulous, dedicated, hardworking, honest and ethical.

"I wanted to thank you for your vote of confidence. I thank all the citizens of this fine city for being so nice and their support over the years," said Maciag. "I started my career here 17 years ago. I am very proud to be chief. The fine men and women of this department are the best of the

Maciag and his wife, June, have two sons, Jacob and Alex. He earned his bachelors degree in criminal justice from Western Michigan University and a masters degree in criminology from Eastern Michigan University. He also completed the FBI Academy in 2012 and the Northwestern University Staff and Command School.

Maciag, formerly Wyandotte, said he has specific goals for the department despite the financial problems facing the city which is in a deficit budget situation.

"I'd also like to be more involved in the community. There are some technology things I would like to see us move towards," he said. "I want to be more accessible to the community - they are our ally and help us tremendously."

# 2 charged in shooting death of Westland man

Two men have been charged in the shooting death of a 79year-old Westland man.

Prosecutor Kym L. Worthy has charged Dale Morgan, 42, of Ypsilanti and Cortez Butler, 42, of Detroit with the homicide of Charles Graham who was killed shortly after 5:30 a.m. Dec. 6. Prosecutors allege that Graham met with Morgan in the early morning hours of Dec. 6 and they went to a house in the 9300 block of Woodlawn in Detroit. The pair met Butler and shortly thereafter the three got into a nearby car.

While in the vehicle, prosecutors claim, Butler handed Morgan a bottle of pills and demanded money. There was a dispute between the men and when Graham refused to give Morgan money, Morgan shot him in the head with a hand-

Investigators said that Butler and Morgan fled the scene but following an investigation by the Detroit Police Department detectives, were arrested Dec. 11.

Morgan has been charged with First Degree Murder, Felony Murder and Felony Firearm, according to the prosecutor's office. He was arraigned Dec. 13 and remanded to jail. Butler has been charged with Felon in Possession of a Firearm and Felon in possession of ammunition and was also arraigned Dec. 13. He received a bond of \$1 million.

Preliminary court examinations for both defendants are scheduled for Dec. 23 in 36th District Court.

ment amount subsequently accepted by both Sanders and the city.

"Once the case evaluation was complete, we settled very quickly," Ruark said.

The settlement agreement includes a confidentially clause which prevents either side from revealing the amount of the payment from the city or city insurance carrier to Sanders, Ruark said.

"It is very confidential, but I will say the settlement was not extravagant. It was not our intent to drain anybody financially. We wanted to make a statement and that's what we did," Ruark said.

Sanders also refused to disclose any terms of the agreement.

"I feel the settlement agreement is equitable and I am very happy with the results. That being said, this was never about the money for me. This was about not allowing the climate of entitlement and intolerance in city hall to continue. This was about setting an example for others who think they have no recourse against the misuse of authority or the misconduct of those in elected office," he said.

Monit said the settlement amount would be paid to Sanders by the city or the

city insurance carrier and did not indicate that he would be paying any of the settlement amount personally.

"I'm glad it's settled. I feel the amount settled on was appropriate for the nature of the case which had no basis," he said. "I'm glad it's behind me and I'm ready to move forward. I'm glad to be rid of that burden."

Sanders said that he would not hesitate to take legal action again in the same situation.

"I will not allow myself to be a part of, or calmly accept, being the target of immature, baseless gossip and innuendo that seems to have become commonplace and acceptable today and I hope that others who have been maligned by this kind of juvenile prurience follow my example and seek legal redress," he said.

"I am glad this battle in the war is done and I am more than pleased with the results. I hope we can all move forward in a more respectful and civilized manner and work toward making our city a better place," Sanders said.

Monit, too, said the case was "reasonably settled."

"I'm happy and satisfied it's over with and the city is happy," Monit said.

"Mr. Monit made a mistake. Hopefully, now that this is all settled, we can all move forward." Ruark said.



strip to their underwear and loaded them into the trunk of a car, according to testimony in the court. The teens were found five days later in an abandoned field in Detroit shot execution style.

Testimony indicated that Hunter told others that he and Young drove around for about an hour before finding the "perfect spot." where the teens were taken into the field where they were found, forced to kneel and fatally shot. A witness also said that Hunter told him that the car the teens were driving was doused with bleach and burned. The car was located on Beechwood in Detroit covered in a cleaning solvent but not set on fire, according to police reports. The Chevrolet Cavalier was located the day after the teens went missing and several days before their bodies were found. Stereo equipment had been stripped and stolen from the vehicle by two men living near where the car was abandoned. The men who took the equipment from the car were later arrested and suspected of the shootings, but further investigation cleared them of the killings, according to court records.

Hunter is already serving a sentence of life without parole for the murder of Vietnam veteran John Villneff on Rutland Street in Detroit in August 2012.

VIOLATION AND PENALTY Any person or entity found responsible for a violation of this Ordinance shall be guilty of a civil infraction and may be fined a civil not more than \$100.00, plus any costs and fees that may be imposed by the court. SEVERABILITY If any clause, sentence, section, paragraph or part of this Ordinance, or the application of thereof to any person, firm, corporation, legal entity or circumstances, shall be for any reason adjudged by a court of competent jurisdiction to be unconstitutional or invalid, said judgment shall not affect, impair or invalid the remainder of this Ordinance. It is hereby declared to the legislative intent of this body that the Ordinance is severable, and that the Ordinance would have been adopted had such invalid or unconstitutional provisions not have been included in this ordinance. # Results of federal investigation still unknown

Tension is apparently building as questions remain unanswered while the Department of Justice continues a forensic audit and investigation in the Plymouth Township Police Department.

Officials in Washington last week again refused to confirm or deny the criminal nature of the ongoing investigation.

John Lavinski, spokesperson from the DOJ Office of the Inspector General, said the department investigators were attempting to provide a formal response as to "What's right and what's wrong and how they (the township) was going to correct

The ongoing audit of the drug forfeiture funds of the Plymouth **Township Police Department** required township officials to

provide specific and detailed information regarding use of the \$1.6 million revenue listed on the 2012 annual township report.

Three auditors from the Chicago office of the Drug **Enforcement Division of the** Department of Justice arrived at the Plymouth Township Police Department last August to audit the accounting records regarding the drug forfeiture funds.

To date, Department of Justice

agents have spend countless hours, 12 days and three visits to the township offices and police department. After the first visit last August, three auditors returned for four days and later two more auditors returned for four days.

Lavinski said he'd prefer to call it (the investigation) "a factual accuracy review" and said he could not provide a timetable as to when the federal investigation

might be complete. He said the 12 days was not unusual in the case of Plymouth Township.

A recent similar investigation in New York City lasted only one week, Lavinski said.

"Audits take a long time, month and months."

At the last regular board of trustees meeting, Township Clerk Nancy Conzelman acknowledged the federal agents were still there working.

#### Fire displaces residents at Water's Edge complex

Water's Edge Apartments in Belleville last week remains under investigation by the Van Buren Township Public Safety Department.

Rescue workers were called to the apartment complex at about 5:18 p.m. Dec. 10 in

response to a reported fire at the structure. Van Buren Township Police officers were first on the scene and discovered the south side of the building in flames. Officers immediately began evacuating residents, according to police reports of the incident. Fire

fighters arrived and assumed the evacuation efforts and initiated fire suppression procedures, according to reports and requested assistance through mutual aid from the City of Belleville, Romulus and both Ypsilanti and Sumpter town-

Reports indicated that the Van Buren Township Animal Control officer was called to the scene to assist with the safe removal and temporary lodging of several pets that had to be evacuated from the building.

Residents were temporarily sheltered at Van Buren American Red Cross was on site to assist the displaced residents. police said.

#### CITY OF ROMULUS **ORDINANCE NO. 2014-009**

ORDINANCE AMENDING PART II CHAPTER 2 ARTICLE V DIVISION 3, ACQUI-SITION AND DISPOSITION OF CITY-OWNED PROPERTY, SECTIONS 2-325, 2-326, and 2-327, 2-330, and 2-331 of the CODE OF ORDINANCES FOR THE CITY OF

THE CITY OF ROMULUS ORDAINS:

Part II Chapter 2 Article V Division 3 Sections 2-325, 2-326, 2-327, 2-330, and 2-331 are amended to read as follows:

Sec. 2-325. Purchase of properties in foreclosure.

The property disposition committee shall meet and recommend to council the purchase of any property located in the city that has been foreclosed for failure to pay property taxes that is available for purchase by the city under MCL 211.78m(1)&(2) by the payment of the minimum bid, which represents all unpaid tax, interest, and penalties, where the committee determines there is a public interest to be served in such purchase.

The property disposition committee shall also meet and review the list of properties located in the city that have not sold in previous foreclosure sales that pursuant to MCL 211.78m(6) shall be transferred to the city unless it files objections thereto, and recommend to the council a list of parcels that should be rejected.

Sec. 2-326. Property not redeemed. This section shall be deleted in its entirety.

Sec. 2-327. Requirements for the sale of property.

All property owned by the city that is determined to be sold, except property (1) that is part of open space, common areas, or used for retention or detention in a subdivision or condominium which shall be sold at the City's costs as set forth in Section 2-330 to the respective homeowners association or (2) sold in compliance with MCL 117.4k, which are not required to comply with the requirements set forth below, shall be sold under one of the methods described below:

(a) Any property that the committee designates for sale may be listed for a period of six months, with a broker doing business in the area, which listing agreement shall provide that the sale is subject to council approval.

(b) Any property that the committee designates for sale shall be posted with a for sale sign and shall be advertised for sale for at least two consecutive weeks in such sources of advertising that the clerk shall deem advisable, requiring sealed bids to be submitted to the clerk. This process shall be repeated every year for property designated to be sold to the public.

The remainder of Section 2-327 shall remain unchanged. Sec. 2-330. Offers to purchase or bids.

(5) Property that is sold by the city shall be sold at a price that shall include at least the city's cost of purchase, all improvements thereto, and all administrative costs, and may include a deed restriction that limits the future use of the property to uses identified in the deed or it shall revert

(6) Property that is sold or given by the city for civic, artistic or cultural activities in compliance with MCL 117.4k, the city is required to recover its costs of purchase of improvements or administrative costs.

Sec. 2-331. Environmental review.

This section shall be deleted in its entirety.
