

**CITY OF ROMULUS INVITATION TO BID**  
**ITB 23/24-15 Upfitting Police Utility Interceptors**

The City of Romulus, Michigan Police Department is seeking bids from qualified companies for the upfitting of purchased new Ford Police Utility Interceptors.

- (1) Qualified individuals and firms wishing to submit a bid must use the forms provided by the City. Official bid forms and specifications may be obtained from the MITN Purchasing Group page of BidNet Direct (<http://www.mitn.info/>). Bids may be rejected unless made on the forms included with the bidding documents.
- (2) Contractors that desire to submit a bid can view the equipment that will be removed from existing vehicles as part of this solicitation at the City of Romulus Police Department located at 11165 Olive Street, Romulus, Michigan. Viewing will be by appointment only and appointments must be completed no later than 12:00 noon, 5/17/2024. - (4) Clarifications, modifications, or amendments may be made to this solicitation at the discretion of the City. Any and all addenda issued by the City will be posted on the MITN Purchasing Group page of BidNet Direct. All interested parties are instructed to view the MITN website regularly for any issued addenda. It is the responsibility of the bidder to obtain all issued addenda and acknowledge receipt of said addenda by including a printed copy of each addendum as part of the required documents for this solicitation and to list the addendum and sign and date the "Acknowledgment of Receipt Addenda Form: supplied in the bid documents.
- (5) A total of two copies (one marked "Original" and one marked "Copy") of the bid must be submitted together in one sealed package/envelope and returned to the **City Clerk's Office** no later than 2:00 P.M., **Thursday, 5/30/2024**. Bids should be addressed using the bid package label provided in the solicitation documents or submitted electronically on the MITN Purchasing Group page of BidNet Direct.
- (6) At approximately 3:00 p.m., local time **5/30/2024**, all timely received bids will be publically opened and read.
- (7) The City reserves the right to postpone the opening without notification and also reserves the right to reject all bids and to waive any minor informality or irregularity in bids received and to award the bid in whole or in part. Ultimately, a contract may be awarded to the lowest most responsive and responsible company, as determined in the sole discretion of the City of Romulus or otherwise in a manner deemed by the City to be in its own best interest.
- (8) The successful Bidder will be required to submit proof of all bonds and insurance required by the solicitation documents and copies of all required endorsements.
