

## CITY OF ROMULUS Planning Commission SPECIAL MEETING

Notice of a Public Hearing MONDAY, **April 7, 2025 – 7:00 pm** 

Notice is hereby given that the City of Romulus Planning Commission will hold a **special meeting** including a public hearing at **7:00 p.m.** on **MONDAY**, **April 7**, **2025** for the purpose of considering the following:

- 1. **Super Y Plaza** requesting a zoning map amendment (conditional rezoning) and special land uses for:
  - a. RZ-2024-002; to conditionally rezone (zoning map amendment) a portion of Parcel DP# 80-044-01-001-300 and DP# 80-044-01-0009-301 (Lots 6 12) from C-2, General Business District to C-3, Highway Service; DP# 80-044-01-0062-300, 80-044-01-0061-000, 80-044-01-0060-000, and 80-044-01-0058-000 (Lots 58 62): and 80-044-01-0013-304 and 80-044-01-0018-300 (Lots 13 30) from R-1B, Single Family Residential to C-3, Highway Service;
  - b. SLU-2024-003; special land use approval to allow a vehicle service center/fueling station in accordance with 11.07(f); and
  - c. SLU-2024-004; special land use approval to allow a drive-thru restaurant in accordance with Section 11.06(a).

The property is located at 7130 Middlebelt Road.

- 2. Gem Seal (PMG Sealmaster) requesting a zoning map amendment (rezoning) for:
  - a. RZ-2025-002; to rezone 28055 Van Born Road (Parcel DP# 80-001-99-0015-000) from M-1, Light Industrial to M-T, Industrial Transportation for the purpose of expanding the business at 27989 Van Born Road Van Born Road.

The public hearings will be held at Romulus City Hall Council Chambers, 11111 Wayne Road.
